HOSPITAL READMISSIONS

Hospital readmissions in New York State cost \$3.7 billion per year. 15% of all initial hospitalizations result in a readmission within 30 days, which translates to nearly 274,000 additional hospital stays. A significant proportion of re-hospitalizations could be prevented if systems were put in place aimed at identifying and
